



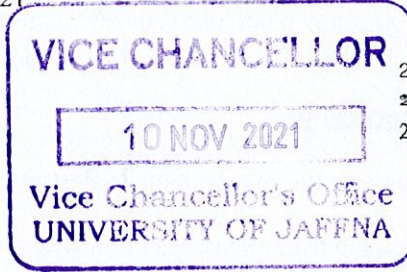

**Ref: Request for Cooperation -
Survey of Online Learning in Higher Education in Sri Lanka**

As you may recall, we conducted rapid assessment on online learning in higher education to understand impact of the coronavirus disease (COVID-19) based upon the request from the Office of the President through the Presidential Taskforce on Sri Lanka's Education Affairs. The results of the online survey were published with the support of ADB (<https://www.adb.org/sites/default/files/publication/635911/online-learning-sri-lanka-during-covid-19.pdf>) and it became useful inputs for addressing online higher education.

However, new challenges could emerge due to long closure of higher education institutions, and understanding current challenges could be also useful to think about blended learning approach when higher education institutions could reopen their campus. With this backdrop, I would like to seek your support in conducting follow-up surveys on online learning in higher education. Similar to last year, the survey will use the same online platform called *SurveyShare* with the support from Asian Development Bank (ADB). The final report will be made available and respective university can use it as a reference for future development of online higher education.

The specific objectives of the follow-up survey are;

- (i) to assess the current utilization of online learning of students in universities and higher education, particularly under COVID-19
- (ii) to understand the challenges faced by university administrations, their faculty members, and students in online learning
- (iii) to help define programme opportunities for online learning in Sri Lanka.

Respondents

As we did last year, three separate online surveys would be administered to three groups of respondents: students, faculty and university/HEI administration. The information is encrypted and will be kept strictly confidential, not be shared with any third party, and the analysis will be conducted in aggregate form and will not be used to identify specific individuals.
